

General Employment Agreement

Between: Iam Anrpa, an individual with a main address at:

And: Medical Imaging Group, a corporation organized and existing under the laws of
the State of Wyoming, with its head office located at:
3904 Whitney Road
Cheyenne, WY 82007

In consideration of the matters described above, and of the mutual benefits and obligations set forth in this Agreement, the parties agree as follows:

Employment

Employer employs, engages, and hires employee as an RPA to be a physician extender with regards to patient assessment, patient management and provide a broad range of radiology diagnostic and interventional services and employee accepts and agrees to such hiring, engagement, and employment, subject to the general supervision and pursuant to the orders, advice, and direction of employer.

Best Efforts of Employee

Employee agrees that she/he will at times faithfully, industriously, and to the best of her/his ability, experience, and talents, perform all of the duties that may be required of and from her/him pursuant to the express and implicit terms of this Agreement, to the reasonable satisfaction of employer. Such duties shall be rendered at 3904 Whitney Road, Cheyenne, WY 82007 and at such other places as employer shall in good faith require or as the interest, needs, business, or opportunity or employer shall require.

Term of Employment

The term of this agreement shall be a period of two years, commencing January 1, 2014 , and ending on December 31, 2016. At the expiration date of December 31, 2016, and every two years after this date, this agreement shall be re-evaluated.

Compensation of Employee

Employer shall pay employee, and employee shall accept from employer, in full payment for employee's services under this agreement, compensation at the rate of \$90,000 per year payable twice a month while this agreement shall be in force. Employer shall pay employee 75% (\$67,500) of salary rate during the duration of employee's school. Once employee is certified the employer should continue with full rate compensation to employee. Every year on hire date employee's salary rate shall be increased 5%.

Employer shall reimburse employee for all necessary expenses incurred as an employee while traveling pursuant to employer's directions.

Vacation

Employee shall be entitled to 3 weeks of paid vacation each year during the term of this agreement, the time for such vacation to be determined by mutual agreement between employer and employee.

Reimbursement of Expenses

The employee may incur reasonable expenses for furthering the companies business, including expenses for continuing education, travel, and similar items. The company shall reimburse employee for all business expenses after the employee presents an itemized account of expenditures, pursuant to company policy.

Benefits/Insurance

The employer should have a health insurance plan and benefits plan, including health insurance, dental insurance, disability insurance, sick days and also include funds for continuing education, available to the employee, if desired by the employee.
